#### PRIVACY POLICY

#### Information pursuant to Article 13 of Regulation (EU) 2016/679

### 1. Identity and Contact Details of the Data Controller and Its Representative

The Data Controller is Almacis, with registered office at Via Giuseppe Carducci 83 Pescara (PE). Any request regarding personal data processed by the Company may be sent to the indicated registered office or by writing to the email address info@almacis.it.

### 2. Purpose of Data Processing and Legal Basis

Regarding technical cookies, the legal basis for processing is the legitimate interest of the Controller (Art. 6, paragraph 1, letter f) of the GDPR), represented by the need to optimize the browsing experience. Regarding analytical cookies, the legal basis is the user's consent (Art. 6, paragraph 1, letter a) of the GDPR).

#### 3. Recipients or Categories of Data Recipients

In pursuing the purposes stated in section 2, access to the data may be granted to the following recipients:

- a) Individuals authorized to process personal data under the direct authority of the Controller;
- b) Skipso LTD as the data processor for IT services.

#### 4. Transfer of Data to a Third Country or an International

Organization The Controller may transfer personal data to an International Organization or to countries within the European Union and/or non-EU countries in compliance with the purposes outlined above. Such transfers will occur exclusively based on and in accordance with Chapter V, Articles 44 and following of the GDPR, which are fully incorporated herein.

For personal data processing outside the EU, the Controller will authorize such processing only when the data transfer is based on an adequacy decision by the Commission (Art. 45 of the GDPR). In the absence of an adequacy decision, the transfer may only occur if appropriate safeguards are provided as per Article 46 of the GDPR, or in cases explicitly provided for under Article 49 of the Regulation.

#### 5. Completion of Data Collection Forms

The data will be processed to fulfill the specific requests of the data subject. In particular, by clicking the "login" button, access will be granted to a reserved area with registration and login options for a partner company profile or an Innovative Subject profile.

#### 6. Retention Period of Personal Data

The data retention period is indicated in the above section B.

### 7. Data Subjects' Rights

# 7.1 Right of Access, Rectification, Erasure, and Restriction of Processing You have the right to request:

- Access to data: the right to obtain confirmation from the Controller whether personal data
  concerning you is being processed and, if so, to access your personal data and related
  information. If personal data is transferred to a third country or an international organization,
  you have the right to be informed about the existence of appropriate safeguards under current
  regulations.
- Rectification of data: the right to obtain the correction of inaccurate personal data concerning
  you, as well as, considering the purposes of processing, the integration of incomplete personal
  data, also by providing an additional statement.
- Erasure of data: the right to obtain the deletion of personal data concerning you in cases provided by applicable law.
- Restriction of processing: the right to obtain the restriction of processing in cases provided by applicable law. If processing is restricted, personal data may only be processed with the data subject's consent, for legal claims, or to protect the rights of another natural or legal person.

#### 7.2 Right to Data Portability

Where processing is based on consent or a contract and is carried out by automated means, you have the right to receive the personal data concerning you in a structured, commonly used, and machine-readable format, and the right to transmit those data to another data controller.

In exercising your portability rights, you also have the right to have your data transmitted directly from one controller to another where technically feasible. The exercise of the right to data portability does not affect the right to erasure. This right does not apply to processing necessary for the performance of a public interest task.

## 7.3 Right to Object

You have the right to object, at any time and for reasons related to your particular situation, to the processing of personal data concerning you when processing is necessary for performing a task in the public interest or for the legitimate interests of the Controller or third parties, including profiling based on these provisions.

If personal data is processed for direct marketing purposes, you have the right to object at any time to the processing of personal data concerning you for such purposes, including profiling to the extent it is related to direct marketing.

If you object to processing for direct marketing purposes, your personal data will no longer be processed for these purposes. Furthermore, if personal data is processed for scientific, historical research, or statistical purposes, you have the right to object for reasons related to your particular situation unless processing is necessary for performing a task in the public interest.

### 7.4 Exercising Rights

Any request regarding the exercise of the above rights may be sent to the Data Controller using the contact details provided above.

#### 7.5 Right to Withdraw Consent

If the processing of your personal data or special categories of personal data is based on consent, you have the right to withdraw consent at any time. In this case, processing carried out before the withdrawal will remain unaffected. Consent may be withdrawn by sending a specific request to the Controller at the provided contact details.

## 7.6 Right to Lodge a Complaint with a Supervisory Authority

If you believe that processing concerning you violates applicable law, you have the right to lodge a complaint with a supervisory authority, in particular in the Member State where you reside, work, or where the alleged violation occurred.

#### 7.7 Right to Refuse Data Provision

Providing data is not mandatory. If you refuse to allow the installation or use of cookies (see section B), the website may experience functionality issues, some operations may not be possible or may be more complex, and achieving the purposes indicated in section 3 and section B concerning individual installed cookies may not be feasible.

## **COOKIE POLICY**

#### **COOKIE POLICY PURSUANT TO ARTICLES 13 AND 14 OF THE GDPR**

Cookies are small pieces of data that are temporarily stored in the browser memory of the user's device. The Portal uses cookies in compliance with the GDPR, the Privacy Code, and the guidelines of the Data Protection Authority on the subject (provisions "Identification of simplified procedures for the information and acquisition of consent for the use of cookies" – May 8, 2014, "Clarifications regarding the implementation of cookie regulations" – June 5, 2015, "Guidelines on cookies and other tracking tools" – June 10, 2021).

If personal data of users is collected through cookies, please refer to the privacy policy (particularly regarding the purposes of processing, the retention period of collected personal data, data recipients, user rights, etc.).

## Cookies can be distinguished:

- By their duration:
  - o (i) Session cookies: stored for the duration of the browsing session;
  - o (ii) Persistent cookies: stored for a predetermined period;
- By the entity placing the cookies:
  - (i) First-party cookies: placed on the user's device by the site manager (the publisher) of the website being visited;
  - o (ii) Third-party cookies: placed on the user's device by an entity other than the publisher but through the publisher itself;
- By their purpose.

# The Portal only installs first-party session cookies. Below is a detailed description of the types of cookies used and their respective purposes:

- Technical navigation cookies: These cookies are essential for navigating the Portal and using all its features, such as accessing protected areas. Some of these cookies are provided and managed by Skipso LTD and are necessary to ensure the proper functioning of the Portal, allowing users to navigate and use basic functionalities. Without these cookies, certain necessary services, such as form submissions, cannot be used. These cookies do not collect information that could be used for commercial purposes. For the Portal to function correctly, technical navigation cookies must be enabled, as disabling them may prevent or significantly hinder navigation on the Portal.
- Technical functionality cookies: These cookies allow the Portal to remember user choices (such
  as name, language, or region) and provide personalized, advanced functionalities. They may
  also be used to remember changes made to text size, fonts, and other customizable elements
  of web pages. Some of these cookies are provided and managed by Skipso LTD. These cookies
  do not collect information for commercial purposes.
- Performance (or analytical) cookies: These cookies collect information about how users interact with the Portal or if they encounter error messages from web pages. They do not collect information that identifies a visitor. All data collected through these cookies is aggregated and anonymous. They are used solely to improve the functionality of the Portal. These cookies are stored and managed directly by the Joint Controllers, making them equivalent to technical cookies. These cookies do not collect information for commercial purposes.

## The installation of the above-mentioned cookies does not require user consent.

If you wish to disable cookies, you must customize your computer settings by either deleting all cookies or enabling a warning message when cookies are stored. To proceed without modifying cookie settings, simply continue browsing. Most browsers allow users to control cookies through their settings. However, please note that completely or partially disabling technical cookies may affect the usability of the Portal's features.
